# Eligibility Rules for Fiesta del Sol Entries

1. The DEADLINE for all submissions is **July 3, 2009!**
2. The **Fiesta del Sol** is open to all unsigned and signed artists
3. All styles and genres of music are welcomed and accepted.
4. Each artist must submit a complete artist package complete with bio, picture, and CD with at least 3 original selections. **No packages will be returned.**
5. Each song submitted must be the contestant's original work; no song previously released or nationally distributed work from another recording artist will be eligible.
6. Entries are judged on Songwriting, Quality of Content, Overall Vibe, Musical Performance, Vocal/Lead Instrument Performance, and Originality. Genre and production quality are not a factor.
7. All artists selected must be open to perform at **Fiesta del Sol** either **August 8th or August 9<sup>th</sup> 2009.**
8. All artists selected must perform music with no profanity or obscenities.
9. All artists must sign an Affidavit of Eligibility stating that if chosen the artist music, is the artist's original work and that he/she holds all rights to the song.
10. A parent or guardian must undersign affidavits of any artist under 18 years of age. Affidavits are subject to verification of **Fiesta del Sol** and its agents.
11. This Entry constitutes permission to use performers name, likeness and voice for future advertising and publicity purposes without additional compensation.
12. All artist must sign an Insurance waiver for stage liability prior to or on the day of the event.
